Co-op's General Manager To Retire On September 1

Brent Sykora, the co-op's general manager, has announced he will retire from Red River Valley REA on September 1, 2023.

After general manager Lynn Puckett hired him as a fulltime lineworker in 1992, Sykora rose to become the co-op's fifth CEO/general manager in 2019.

During his 31-year fulltime career, Sykora served in nearly every capacity offered by each department.

"It has been a privilege to serve in so many areas," Sykora said. "I feel my experiences molded me as general manager to appreciate every employee's duties. I could step in and assist when needed."

After receiving a call from Ron Willis (assistant manager at the time), Sykora began his association with Red River Valley REA as an 18-year old in 1989, working on line construction crews while



attending college.

He graduated from Southeastern Oklahoma State University in 1992 with a bachelor's degree in business management and minors in math and accounting.

Sykora engaged in power line construction, primary and secondary voltage, metering, service work, power quality, and after-hours outage calls until 2000.

He then joined manager Brent Hartin's supervisory/management staff and dealt successively in budgetary management, government loan procurement, and management of distribution services. He was made assistant manager in 2017.

Sykora grew up in a military family, which settled in Marietta upon his father's retirement from the U.S. Air Force. Brent graduated from Marietta High School in 1988. He and his wife Tina have been

married since 1992.

They have three daughters and one son-in-law, Mallory Langley and husband Dalton, Bailey, and Mandy.

Sykora has been an active member of Shady Dale Baptist Church since his teens. His hobbies are fishing, hunting, outdoor activities, and spending time with family and friends.

"I want to thank all of my family for their support through the years," he said. "And, though I can't list all the names, I am very appreciative of the coworkers, supervisors, managers, and Board members I worked with throughout my career."

He promoted Mike Mathis, vice president of office and members services, to assistant manager.

The Red River Valley REA Board of Trustees has endorsed Mathis to succeed Sykora as CEO/general manager.

Student Essayists Win Awards from REA

The top two finalists in the co-op's annual Youth Tour essay contest were awarded all-expense paid travel to Washington D.C. Emarie Butler, Ringling, and Nathan Pearson, Thackerville, will join winning essayists from co-ops around the nation in June for tours of the U.S. Capitol and meetings with members of Congress and government agencies.

Gabbie Anthony, Thackerville, finished third, and was awarded \$500. Rachel Smee of Marietta, won \$400

for fourth place. Keagan Balch, also of Marietta, finished fifth and received \$300.

Junior students in the co-op's service area chose their own topics. They each fashioned a professional letter to a local, state, or federal elected official about an issue that was important to them.

Five finalists then delivered a speech on their essays for judges at the co-op's Youth Tour Banquet in March.

In the middle school division, eighth graders wrote on the topic, "What

Would Life Be Like Without Electricity?" The top six writers (above) will represent the co-op at Energy Camp in Hinton, OK, in June.

The camp introduces students to career choices with cooperatives. They will witness high voltage demonstrations and ride in a bucket truck, as well as share in team building activities and recreation. KorDale Lornes, director of member services, supervised the essay contests.

Co-Op Names Top Senior

STEPS POWER OUTAGES



1. Transmission Transmission lines can supply many substations that power tens of thousands of people. If damage occurs here, it gets first attention.

2. Substation
Substations serve thousands and are checked to determine if the problem is on the transmission or distribution side.





- 3. Distribution Feeders
 Once feeder lines are repaired,
 members on that line should see power
 restored, as long as there are no
 problems downline.
- 4. Distribution Taps
 The final supply lines that carry power
 to the transformers outside your homes
 and businesses are then repaired.





5. Service/Secondary
If isolated outages persist, damage on the secondary line may be the reason your neighbors have power but you do not.

Speak to a Live Representative 24 Hours a Day

A live representative is always available to take your call, 24 hours a day, seven days a week, at (580) 276-3364.

During normal business hours, the telephone is answered by a customer service representative.

After hours, calling the co-op brings up a recording. Listen to the prompts, then to report an outage, press 1 and a live representative will answer.

How and When To File for the Office of Trustee

You, the members/owners of Red River Valley REA elect a Board of Trustees that hires a professional manager to run the electric cooperative. The trustees are members, too, and live in the areas they represent.

- The filing period for trustees is June 30-July 14.
- Filing papers may be picked up at either co-op office during regular weekday hours beginning on

To ensure that all parts of the co-op territory are represented, three geographic districts have been established (**See map below**).

Each district has three offices. Trustees in these offices serve three-year terms. The terms are staggered so that the term of one trustee from each district expires each year. In 2023, Office 3 of the districts is up for election.


DISTRICT 1, OFFICE 3 is held by Allen Wade of Ringling. Wade's seat is up for election.

DISTRICT II, OFFICE 3 is held by Larry Hicks of Jimtown. Hicks' seat is up for election.

DISTRICT III, OFFICE 3 is held by Phillip Landgraf of Madill. Landgraf's seat is up for election.

The election takes place at the 86th Annual Meeting on Monday, August 14, 2023.

- Voting is at large, not by district.
- Regardless of where a member lives, he or she votes in contests for all three offices.



Our Districts

District I covers all cooperative members who live in Carter County and Love in Jefferson County and those who live in Carter County and Love County west of the section line two miles east of Highway 76.

District II covers all coop-

erative members who live County east of the section line two miles east of Highway 76.

District III covers all cooperative members who live in Marshall and Johnston Counties.

Highlights of Trustee Qualifications Rules

The candidate must comply with the general trustee qualifications section of the By-Laws of Red River Valley REA and the decisions of the Credentials and Election Committee. A summary of key provisions is shown below.

Nomination

Nomination to the Board requires a petition signed by at least 15 fellow members (one signature per membership) of the district from which the nominee is running. Filing packets are available at the Marietta headquarters and the Kingston office beginning June 16.

Filing

Petitions of nomination must be filed with the co-op at least 30 days before the Annual Meeting. The filing period this year begins on June 30 and closes at 4 p.m., Friday, July 14. Filing packets must be returned by July 14.

Qualification

A candidate must reside in the district in which he or she is running for at least one year before becoming a trustee. A candidate may not be an employee of the co-op during the seven years before running, nor have a close relative who is a trustee or employee.

Also, a candidate or close relative may not be employed by or have a significant financial interest in a business selling electrical energy or electrical supplies to the co-op or to any competing enterprise.

A candidate must not have been

convicted of a felony or pled guilty to a felony during the five years before running.

Voting

Voting for trustees takes place at the Annual Meeting. Each co-op member is eligible to vote for one candidate from each district. The candidate from each district receiving the highest number of votes is elected. Ties are decided by lot.

Compensation

Trustees receive no salary, but they do receive a per diem allowance for travel to meetings. Regular Board meetings occur monthly. Also, trustees are eligible to join the employee benefit plans of the co-op. These include health and life insurance.

The guests visit a substation to learn how electrical distribution works. At headquarters, they can ask questions of maintenance, safety, customer service, metering, and home energy savings specialists, as well as engineers, accountants, managers, mechanics, lineworkers, and dispatchers.

- ✓ Peak days are when the cost to the co-op to purchase and produce power is at its highest.
- ✓ You will receive e-mail, Facebook, or text notification of declared peak power usage days.

Co-op Sends Capital Credit Checks

Red River Valley REA mailed checks totaling \$1,541,834 to certain members in December 2022. The payments represented fully retired REA Capital Credits for the years 1996 through 1998, partial retirement of REA Capital Credits for the years 1999 through 2021, and fully retired Western Farmers Electric Coopertive Capital Credits for the years 2000 and 2001.

A total of 11,109 active and inactive members were eligible to share in the refund checks. Each Capital Credit check was based on the consumer's total electric bill during the refund periods. The co-op Board of Trustees approved the action last fall.
